Dear Dr. Nahar,

We are pleased to inform you that you have been awarded a Research Fellowship for women and minorities by the College of Mathematical and Physical Sciences at the Ohio State University in the Dept. of Astronomy. You are hereby offered an appointment as Postdoctoral Research Associate. Your appointment may extend up to a period of three years, based on mutual agreement and favourable annual reviews.

Your annual stipend will be \$33,600, which will breakdown as follows. Base Stipend: \$30,000; allowance for purchase of benefits: \$2,303; provision for taxes on the allowance for benefits: \$1,214; amount needed to round up stipend to multiple of \$120: \$83. In addition, you can draw on \$2,000 of discretionary funds for supplies, services and travel.

As you know, you will be working with Prof. Anil Pradhan in the Dept. of Astronomy on atomic calculations for astrophysical applications. Your appointment is expected to begin as of June 1, 1990. Please let us know of your decision as soon as possible.
