

FRESHMAN SCHOLARSHIP ACCEPTANCE STATEMENT

The following terms and conditions apply to the Howard University 2011-2012 **Legacy** scholarship. **By initialing beside each statement you agree that you have read and understand the terms and conditions of this scholarship offer.**

___ The **Legacy** scholarship covers tuition and mandatory fees. **The scholarship does not cover the enrollment deposit.**

___ **Legacy** scholarships are awarded for four consecutive years of undergraduate matriculation unless the program of study selected upon initial enrollment at Howard University is designated as a five year or pre-professional program in the University Bulletin. Recipients may not use the **Legacy** scholarship for summer school enrollment.

___ To renew a **Legacy** scholarship, the recipient must earn a minimum of 12 credit hours at Howard University each semester and achieve no less than a **3.00 grade point average each academic year (fall and spring semesters)**. **This is not the cumulative grade point average.** Grade point averages used to qualify for the **Legacy** scholarship may **not** include credit hours earned for Summer School, repeated courses, or courses taken at non-CUWMA schools.

___ If at the end of an academic year, the recipients do not meet the minimum scholarship renewal requirements, the University will discontinue the **Legacy** scholarship with no options for reinstatement. There is no appeal to this condition of the award. However, students can apply and be considered for other scholarships and financial aid if they fail to maintain the minimum requirements to renew the **Legacy** scholarship.

___ **Legacy** scholarship recipients considering domestic exchange, study abroad, and consortium programs must have **approval from the appropriate personnel and contact the Freshman Scholarship Coordinator for the policies to maintaining their scholarship.** Students who have not registered for an approved exchange program will forfeit their scholarship for future semesters with no option for reinstatement.

___ Recipients of the **Legacy** scholarship who are US citizens or permanent residents and their parent(s) or legal guardian(s) must complete and submit the Free Application for Federal Student Aid (FAFSA) by the University's February 15 priority deadline **each academic year** to determine their eligibility for federal financial aid. Please request that Howard University (001448) be sent a copy of the results. The FAFSA can be completed online at www.FAFSA.ed.gov.

___ If the recipient receives additional financial aid funds from other sources (e.g. other scholarships, loans, grants, or awards) the funds must be reported to the Office of Financial Aid, Scholarships, and Student Employment. **The University reserves the right to adjust scholarship awards if award recipients receive additional financial aid above the cost of attendance or for the same purpose (e.g. two tuition scholarships).**

___ Withdrawal from the University before completion of a semester will result in termination of the scholarship for subsequent semesters with no option for reinstatement.

___ The deadline date for notifying Howard University of your acceptance of this award is **May 1, 2011**. If the acceptance statement is not postmarked by the deadline, the scholarship offer will be cancelled.
